### General Business Meeting

#### Distant Drums RV Resort, Camp Verde, AZ March 30, 2017

President Knud Bjornestad called the meeting to order at 9:08 a.m. and stated the meeting had a quorum in attendance.

Rich Beeber led the attendees in the Pledge of Allegiance to our Flag.

Marsha Taylor introduced First Timers Marsha & Ted Lewis, Susan & Bob Martin, Vivian & Joe Lewis and Cathy & Pat Coleman.

President Bjornestad thanked rally masters Raylene & Rich Beeber, Nancy & Jim Lane and Leah & Joe Dingman for hosting an excellent rally. An enthusiastic round of applause from the gallery acknowledged the rally masters efforts and success. Kudos were also extended to Rob Wilson and Larry Johnson chief bartenders, and all of their bar staff.

#### Secretary's Report:

- Secretary Townsend stated that the minutes of the General Meeting held October 6, 2016 at the San Francisco North/Petaluma KOA in Petaluma, CA was published in the most recent newsletter.
- He asked for any additions or corrections. Being none . . .
- He called for a motion to accept the minutes as published. A motion was made and seconded.
- Minutes were passed as published.

#### Treasurer's Report:

- In the absence of Treasurer Karenann Evans, Nancy Baumgart read the Treasurer's report dated March 28, 2017.
- The report stands as read, is included with the official minutes in the Secretary's Log Book and will be published in the Treasurer's Report section in the newsletter in which these minutes are published.

Prior to turning the microphone back over to President Bjornestad, Secretary Tom Townsend took the opportunity to thank Nancy Baumgart for her sitting in for him at the past two rallies as Secretary Pro Tem. She did a great job and it was very much appreciated.

President Knud Bjornestad called on Vice President Stephen Hobbs to discuss the rallies scheduled for the balance of 2017 and into 2018.

Debbie Smith & Janet Ream along with Bobbie & Dave Peterson and Sheryl & Tom Costa are hosting a rally at the Durango RV Resort in Red Bluff, CA. Arrive on Friday, September 22, 2017 and depart on Tuesday, September 26, 2017. They are considering a Shasta Cruise the day before the rally starts but can't confirm anything on this until May 1, 2017.

Donnis Hobbs spoke on behalf of Stephen regarding a rally planned in May 2018 in Sonora, CA as well as a couple of other potential rallies for 2018.

Susan Lewis said the first rally for 2018 will be held in Indio, CA arriving January 7, 2018 and out on January 14, 2018. This is combined with the Western FMCA rally held each year in Indio at this time. They will be parked on blacktop and will have 30amp service. The cost is \$475 per couple for 7 nights including evening dinners. There is no limit to the number of rigs they can accommodate. Monaco Romers provide golf cart drivers for the handicapped during this event.

For anyone interested in hosting a rally contact Vice-President Hobbs and he and Donnis will do everything they can to help you make the rally a success.

#### Membership Chairman's Report:

Webmaster's Report: Webmaster Tom Townsend said that there were some fairly good tools under the Rallies page for new rally masters to help them kick off their rally.

#### FMCA National Director's Report:

- FMCA National Director Jim Lewis said that neither he nor Alternate Director Larry Johnson would be attending the FMCA Convention to be held July 12 15, 2017 in Indianapolis, Indiana and asked for any volunteers so they may be elected as an alternate delegate.
- No one responded.

#### Sunshine & Showers / Romers Apparel Report:

- Sunshine & Showers lady Nancy Baumgart reported that she hadn't received any reports, good or bad although some have come to her attention at this rally. See Sunshine & Showers Report in the newsletter in which these minutes are published for further information.

#### Old Business:

- President Knud Bjornestad stated that after the last business meeting in Petaluma, CA regarding Monaco Romers Standing Rules #1, a committee was formed with Vice-President Stephen Hobbs as its chairman.
  - The committee's objective was to review and recommend changes to Standing Rule #1 to be presented to the Board of Directors.
  - o The committee met several times while they were in Indio in January.
  - o The Board of Director's were presented with the minutes of their meeting and the committee's recommendations for changes to Standing Rule #1.
  - o President Bjornestad stated that the minutes of the above meeting were distributed to the membership at least 30 days prior to today per our By-Laws.
  - o Further, he stated that we have a quorum of 25% of the Chapter family unit membership in that we have 36 family unit members at this rally.
  - o President Bjornestad called for a motion to approve the Special Committee Meeting Minutes. A motion was made and seconded. Discussion followed. Motion passed to accept the minutes as published.
  - o President Bjornestad addressed the three options offered by the committee and asked for a motion and second to consider Option #1.
    - Various members discussed Option #1.
    - It was pointed out that the Board of Directors recommend that Option #1 be approved by the membership.
    - The vote was called for.
    - By a show of hands, a vast majority of the attendees approved Option #1.
  - o Howard Hays made a motion not to vote on Option #2 and Option #3 since an overwhelming majority just approved Option #1. Motion was seconded. Motion carried.
  - President Bjornestad asked for a motion to insert the word "diesel" in the language "Membership is limited to all diesel models with a Monaco logo; including coaches manufactured by Executive Industries and Royal Coach, and all Monaco coaches manufactured prior to 1992 as well as all diesel coaches manufactured..."
    - A motion was made and seconded.
    - Motion passed.

#### **New Business:**

• President Bjornestad stated we have to select a Nominating Committee for the selection of officers for the forthcoming term. Nominating Committee members selected are as follows:

• Rally fees were brought up. It was pointed out that the \$375 figure per coach is just a recommendation. It is up to the rally masters to determine their rally costs and charge accordingly. The \$1,500 stipend is just that. It does not have to be paid back, but rather used to the benefit of the rally and its attendees.

- John Van Doren spoke about the 5<sup>th</sup> Wheelers Baker to Vegas relay race that is open to any member of Monaco Romers as volunteer support along the route. Contact John for more information.
- President Bjornestad called for any other new business. Being none, he called for a motion to adjourn. A motion was made and seconded. Motion passed.

### **Tech Talk**

I was asked to sit in for our regular Tech-Talk moderator, Knud, as he has other duties such as being our outstanding President!

As in the past, we had a great turnout for our talk this time. Since our coaches are not just a coach, but a group of subsystems, it seems there is always something on the repair list. Some of the items that came up at this rally were safety related.

As Steve and Donnis Hobbs left Pismo Beach for the rally, their coach, all of a sudden, would barely run. They were able to limp off of Hwy 101 and found that the clamp holding the exhaust output from the turbo was missing and the tubing disconnected. The hot exhaust melted the wiring in the area. The damage could have been much worse, they were only set back a day and made it to the rally on time.

This brought up a discussion on engine compartment fire extinguishers. It was noted that most diesel pusher coach fires start in the engine compartment and it might be good insurance and not that expensive (compared to a new coach).

Another important safety item is our tow equipment. There was discussion about pins being lost and tow cars trying to pass the coach. In fact, on their way home from the rally, Howard and Judy Hays had one arm of their tow bar become separated from the car near Tehachapi. Luckily, there was no damage and they were able to get a new pin to get home. We should make it a habit to check the tow bar every time we stop.

It seems like there is always talk about our Aqua Hot or water heater or tank monitors and there was no exception this time. Aqua Hot, service it annually. Tank monitors almost always don't work so get used to it or convert to See Level Gauges.

# FMCA National Director / Alternate National Director Report from the 95th International Conference in Chandler, AZ

FMCA's National President Charlie Adcock addressed the 2,376 member families of the association who gathered at the 95th Conference on the "Future of FMCA" International Convention & Expo in Chandler, Arizona to inform the members about some big decisions that the FMCA leaders are dealing with. The future of FMCA depends on growth of our membership and since 2004, when our membership included 130,000 families, we have dropped to about 70,500 families today. Revenue from the current membership is \$ 62.26 per family membership, whereas our expenses are \$78.27. The deficit is made up by withdrawing funds from FMCA's investment portfolio. This cannot continue very long before FMCA will be Bankrupt.

FMCA leadership has concluded that the declining membership can be reversed by opening our membership requirement to include other types of recreational vehicles (RV's), like trailers and fifth-wheels. Surveys have shown that the average age of FMCA members has increased to 71, while RV industry statistics have shown that the average age of RV owners is 48. We need these younger people to consider joining FMCA to enjoy the benefits that our members value. FMCA leaders studied the option of forming a subsidiary organization that would welcome members of other types of RV's to join in the fun of FMCA, however, it was concluded that a better plan would be to simply open FMCA membership to all RV owners. This is the proposal that will come before the Board of Directors in Indianapolis in July this year at the 96th International Convention. If this proposal is approved by the board in July, it will be submitted to the members for a vote in the September, October and November editions of FMCA's Family Motor Coaching magazine. Votes will be counted after November 30th and the results will be communicated to the membership. Charlie Adcock told the members that "RV'ing is less about the equipment used and more about the people who enjoy the lifestyle".

Charlie concluded the presentation with some questions and answers. Here are a few:

- 1. Will Chapters have to allow trailers and fifth-wheels into their membership? Answer: No. Chapters write their own by-laws and that will not change. For example, in order to be a member of the Monaco Romers you must own a Monaco Diesel motorhome.
- 2. Are we going to change the name "Family Motor Coach Association"? Answer: NO, however we will just be using the letters "FMCA" to identify the association. Nobody will have to change their oval placards or business cards.
- 3. Will towables and motorhomes park together at rally? Answer: Yes.
