General Business Meeting  
Red Bluff Fall Roundup  
Durango RV Resort, Red Bluff, CA  
September 25, 2017

President Knud Bjornestad called the meeting to order at 9:32 AM.

Tom Getzfrid led us in the Pledge of Allegiance to our Flag.

President Bjornestad thanked the rally masters Janet Ream, Debbie Smith, Bobbie & Dave Peterson and Sheryl & Tom Costa for hosting such a wonderful rally. The resounding round of applause indicated the members felt the same about the rally.

President Bjornestad then introduced our new member and first timer to a Monaco Romers rally. They are Linda & George McKiernan from Sparks, NV. In addition, he called out Carolyn & Bob Bulot from Palm Desert, CA who joined in 2013 but haven't been to a rally since then.

**Secretary's Report:**

- ï Secretary Tom Townsend stated that the minutes of the General Meeting held March 30, 2017 at the Distant Drums RV Resort in Camp Verde, AZ were published in the most recent newsletter.
- ï He asked for any additions or corrections. Being none –
- ï He called for a motion to accept the minutes as published. A motion was made and seconded.
- ï Minutes were passed as published.

**Treasurer's Report:**

- ï Treasurer Karenann Evans read the treasurer's report effective September 22, 2017.

Their primary function is to provide shuttle service in oversized golf carts to help people in the back 40 get to the featured events area. The Lewis' passed out a flyer on the rally.
- ï John Van Doren spoke to the Spring into the Mother Lode rally being held April 28 – May 2, 2018 at the Mother Lode Fairgrounds in Sonora, CA. ## Tech Talk

There were approximately 30 Monaco Romers that attended Tech Talk which opened with input from members who were having problems.

- When traveling to the Rally, Dave Taylor stated he had a problem putting his hydraulic slides in & out and after much help from a group of people, found the control box located on the front firewall above the generator had accumulated water and many contacts were badly corroded. This box has a seal & supposed to be a water tight box which it was not. Cleaning up contacts got the slides working temporarily and a new HWH box was ordered. Others with similar boxes had a small hole drilled in the bottom. School is still out on where the water came from? Could be from the windshield or heater hoses or Windshield washer???

Many complained of poor/bad headlights. There are some fixes available which have improved night time visibility significantly. They are:

1. Make sure you have 12 amps at the headlight
2. Replace clouded lenses. Google the part number on the front of the lens. (\$65 + or -)
3. Replace the bulb with a higher output bulb available from NAPA and other parts houses. Approx \$50/pair and will add 120 ft. of distance to your lights
4. Re-align you lights (in and out & up and down).

Jerry Plier reported his refrigerator was turned way up and was still not cold. Discussion suggested the \$ bill test to check the seals as they may need replacing, also adjustment of the hinge and checking for frost buildup in the freezer. Might also consider trashing and getting another NORCOLD.

- Curt Curtis reported a "beeping noise" by the door. Comments centered around the alarm system---Check the contact points.

Rob Wilson reported that CoachNet tow insurance does not cover you when an accident is involved, you'll need to use your vehicle's insurance.

There was much discussion about breakdowns happening soon after having you vehicle worked on at repair shops. Check the work, if you can, and know the shop!!!

## Member Vote:

### Proposed Changes To FMCA's Articles Of Incorporation & Constitution

During its meeting on July 12, 2017, FMCA's Governing Board passed a motion to amend the FMCA Articles of Incorporation and the FMCA Constitution so as to change the words "motor coach or motor home" to "recreation vehicle."

If approved by the membership, this will result in owners of the following vehicle definition being eligible for membership in Family Motor Coach Association:

"The term 'recreation vehicle,' as used herein, is defined as a self-contained wheeled vehicle that includes permanently installed cooking, sleeping, and sanitary facilities."

The Governing Board approved this motion with the following rationale:

- As the RV community continues to evolve, FMCA needs to ensure that its mission statement is sufficiently broad to allow the Governing Board to take new and innovative steps to meet the needs and expectations of the membership. This could include the formation of new subsidiaries and associating with other organizations in the RV field.
- Evolution in the RV industry results in sales of different types of RVs fluctuating, so that in some periods sales of motorhomes decline in favor of other RV types.
- Many times friends and relatives who share the RV lifestyle and enjoy traveling together are owners of different types of RVs and, as a result of current policies, forgo membership in FMCA.

If the majority of members who return a ballot approve this proposal, FMCA will become an organization not only for motorhome owners but also for owners of other recreation vehicles that meet the above criteria.
